**Fee Schedule**

**Appointments:**

A completed Pre-Intake History Form and Authorization to Obtain/Release Information Form must be completed prior to scheduling a speech-language evaluation. All appointments are scheduled at Facilitating Growth, West Hartford, CT. Home services can also be provided on an as needed basis.

**Fees/Payments:**

Facilitating Growth is not a participating provider with insurance companies. The service fee reimbursement is dependent upon an individual's plan and it is the policy owner's responsibility to understand their policy's referral requirements and insurance benefits. All documentation (i.e. evaluation report, progress notes, receipt of service, insurance coding, etc.) will be provided to the family when requesting for insurance reimbursement.

**Full payment by cash or check is due at the time services are rendered.**

**Insurance:**

Facilitating Growth will soon be a participating provider with insurance companies (anticipating for September 2016). More specific information regarding insurance accepted and co-pay at time of service will be provided by mid September 2016.

**Services**

***Comprehensive Speech and Language Evaluation:*      **\$550.00 \*****

An initial assessment is required for new clients unless a recent evaluation was performed. An evaluation consists of a combination of informal and standardized assessment dependent on the individual's needs, a complete review of past history and present status and family education. A comprehensive written report regarding findings and recommendations will be provided. Estimated time is 2.5-3.0 hours (2 visits).

\*Additional testing time may be necessary      **\$125.00/hr**

***Evaluation/Consultation:*      **\$175.00 \*****

An evaluation/consultation service is provided for new clients who were previously evaluated and require additional testing or need a more brief evaluation. This consultation consists of review of previous assessments/therapy, additional formal and/or informal

assessment dependant on the individual's needs and family education. A brief written report with findings and recommendations will be provided. Estimated time is 1.5 hours (1 visit)

***Individual Speech/Language Therapy:*** **\$85.00/hr**

Individual therapy is provided following a comprehensive assessment or evaluation/consultation. An individualized treatment plan with specific measurable goals is created based on the individual's strengths and weaknesses and can be updated according to progress. Parent or family education and a home exercise program are typically provided after each session. Estimated time is 1 hour.

***Group Speech/Language Therapy:*** **\$75.00/session**

Group therapy is provided for individuals who have common areas of concern. Specific goals will be targeted weekly and a home exercise program will be provided after each session. The amount of individuals/group, length of time and fees are dependent upon group offered. Estimated time is 1.5 hours.

***Family Education Workshop:*** **\$100.00/1.5 hour**

The Family education workshop consists of discussion of specific areas of concern. Session will include; Information on area of concern, strategies/techniques to create a successful learning environment, and available resources in the community. Written information will be provided. This personal family workshop is provided for one family. Estimated time is 1.5 hours.

***On-site Consultation:*** **\$175.00**

Consultative services are provided for individuals to assess the generalization of a particular skill into the home, school, or work environment. Informal measures of assessment will be performed and treatment strategies will be provided. Estimated time is 1.5 hours.

***Attendance at PPT, 504 meetings and other educational team meetings:*** **\$75.00**

This service is provided only for individuals seen for treatment. It includes a meeting with the family prior to the educational team meeting to review evaluations, recommendations, accommodations and discuss questions/concerns. Additional support will be provided during the team meeting. Time varies (hourly fee).

***Parent/Professional Workshops*** **\$30.00**

Workshops of various topics are provided for parents and educators. Please check for specific time and location of workshops in the community. Visit my website for more detailed information. Space limited to 10 people. Estimated time is 1.0 hour.
